AKTIEBOLAGET ELECTROLUX

MINUTES

from the Annual General Meeting of AB Electrolux held on March 31, 2020, in Stockholm.

Participants:

Shareholders according to the list "Electrolux – Röstlängd", Appendix 1.

The shareholders were welcomed by the Chairman of the Board, Staffan Bohman, who also opened the meeting. The Chairman of the Board recorded that the Board had asked the secretary of the Board, Mikael Östman, to keep the minutes from the meeting. It was resolved in accordance with the Board's proposal to webcast the meeting live on the company's website in order to facilitate for shareholders who were not able to be present in person.

1. Election of Chairman of the meeting

On the proposal of the Nomination Committee, Eva Hägg, member of the Swedish Bar Association, was appointed Chairman of the meeting.

It was also resolved that photography of or recording of sound or images from the meeting, besides the company's own recordings and the webcast approved by the meeting, should not be allowed.

2. Preparation and approval of the voting list

The list, Appendix 1, was drawn up and approved as the voting list for the meeting.

3. Approval of the agenda

The enclosed agenda was approved, Appendix 2.

4. Election of two minutes-checkers

Johan Forssell, representing Investor AB, and Sebastian Iso-Kamula, representing Skandia Liv and Skandia Fonder, were appointed to check and approve the minutes from the meeting together with the Chairman of the meeting.

5. Determination as to whether the meeting has been properly convened

The Chairman of the meeting presented how the meeting had been convened. Thereafter, the meeting was declared properly convened.

6. <u>Presentation of the Annual Report and the Audit Report as well as the Consolidated</u> Accounts and the Audit Report for the Group for 2019

It was recorded that the Board's and the President's Annual Report for the year 2019, which includes the Board of Directors' Report, Income Statement and Balance Sheet as well as the Consolidated Income Statement and the Consolidated Balance Sheet, and the report submitted by the Auditor on the audit of the Board of Directors' and the President's

administration, have been available on the company's website from February 20, 2020, and thereafter in printed version at the company. The documents have also been made public through a press release, sent to shareholders upon request and have been distributed at the meeting. It was further recorded that the statement by the company's auditor regarding whether there has been compliance with the guidelines on compensation to senior management pursuant to Chapter 8 Section 54 of the Swedish Companies Act has been available on the company's website from February 21, 2020, and thereafter in printed version at the company. The document has been sent to shareholders upon request and has been distributed at the meeting.

The above accounts as well as the reports and statement of the Auditor were thus presented to the meeting. The reports are appended as <u>Appendices 3 and 4.</u>

Staffan Bohman held a speech on the work of the Board during 2019.

7. Speech by the President

The President, Jonas Samuelson, held a speech on the Group's business and market situation. Thereafter questions were asked, which the President and the Chairman of the Board Staffan Bohman replied to.

8. Adoption of the Income Statement and the Balance Sheet as well as the Consolidated Income Statement and the Consolidated Balance Sheet

The Income Statement and the Balance Sheet as well as the Consolidated Income Statement and the Consolidated Balance Sheet included in the Annual Report were thereafter adopted in accordance with the recommendation from the Auditor.

9. Resolution on discharge from liability of the Directors and the President

The Directors and the President were discharged from liability for the administration for 2019, in accordance with the recommendation from the Auditor. It was noted that the Directors and the President did not take part in this decision.

10. Resolution on dispositions in respect of the company's profit pursuant to the adopted Balance Sheet and determination of record date for dividend

The meeting resolved in accordance with the Board's and the President's proposal that no dividend should be distributed for the financial year 2019 and that the income for the period and retained earnings of SEK 15,144,722,000 should be carried forward.

11. Determination of the number of Directors and Deputy Directors

The meeting approved the Nomination Committee's proposal that the number of Directors should be nine and that no deputies should be appointed.

12. Determination of fees to the Board and the auditor

The Chairman of the meeting presented the Nomination Committee's proposal, Appendix 5.

It was thereafter determined in accordance with the Nomination Committee's proposal that the Directors' fees should be

- SEK 2,200,000 to the Chairman of the Board and SEK 640,000 to each of the other Directors appointed by the General Meeting but not employed by Electrolux; and;
- for committee work, to the members who are appointed by the Board; SEK 280,000 to the Chairman of the Audit Committee and SEK 160,000 to each of the members of the committee and SEK 150,000 to the Chairman of the Remuneration Committee and SEK 100,000 to each of the members of the committee.

It was noted that the Nomination Committee was of the opinion that the Directors appointed by the General Meeting shall hold shares in the company and that a shareholding of a Director after five years should at least correspond to the value of one gross annual fee.

It was thereafter determined in accordance with the Nomination Committee's proposal that the Auditor's fee be paid as incurred, for the Auditor's term of office, on approved account.

13. Election of Board of Directors and Chairman of the Board of Directors

The Chairman of the meeting presented the Nomination Committee's proposal, Appendix 6.

The meeting voted on the election of each of the proposed Directors under items 13a)-13i). In accordance with the Nomination Committee's proposal it was resolved to, for the period until the end of the next Annual General Meeting, re-elect the Directors Staffan Bohman, Petra Hedengran, Ulla Litzén, Fredrik Persson, David Porter, Jonas Samuelson and Kai Wärn and to elect Henrik Henriksson and Karin Overbeck as new Directors.

In accordance with the Nomination Committee's proposal, Staffan Bohman was re-elected Chairman of the Board for the period until the end of the next Annual General Meeting.

It was noted that the General Meeting had been provided with information regarding the positions in other companies held by the proposed Directors.

14. Election of auditor

The Chairman of the meeting presented the Nomination Committee's proposal, Appendix 7.

In accordance with the Nomination Committee's proposal, Deloitte AB was re-elected as auditor for the period until the end of the Annual General Meeting in 2021.

- 15. Resolution on remuneration guidelines for the Electrolux Group Management
 The meeting resolved in accordance with the Board's proposal on remuneration guidelines,
 Appendix 8.
- 16. Resolution on implementation of a performance based, long-term share program for 2020 No resolution was adopted under item 16 on the agenda as the Board had withdrawn its proposal on implementation of a performance based, long-term share program for 2020.
- 17. Resolutions on a) acquisition of own shares, b) transfer of own shares on account of company acquisitions, and c) transfer of own shares on account of the share program for 2018

The Board's proposal according to items 17 a), 17 b) and 17 c) on the agenda, Appendix 10, was presented to the meeting.

The meeting, after voting by use of voting units, resolved in accordance with the Board's proposal. It was noted that each of the resolutions were approved by shareholders representing at least two thirds of both the votes cast and the shares represented at the meeting.

18. Closing of the meeting

The Chairman of the Board, Staffan Bohman, expressed a thank you to Hasse Johansson and Ulrika Saxon for their efforts during their years as a Directors of the Board. The Chairman of the Board also expressed a thank you to the employee representatives Ulf Carlsson and Joachim Nord for their work with the Board.
